Dear Governor Shumlin,

Vermont is poised for change that is occurring throughout the nation. Our racial and cultural diversity is growing. We can choose to celebrate, embrace, and facilitate the arrival of new neighbors, or we can ignore, misunderstand, and marginalize them. Vermont has a proud tradition of inclusion and social justice that we must vigilantly uphold, in our laws, in our institutions, in our neighborhoods, and in our everyday interactions.

It is only when laws are administered evenly that trust can be built and freedoms upheld for all people who reside within our borders. We cannot truly walk the path of justice until the most voiceless and invisible among us can come into the light and speak freely, or until they can be passengers on a ride home from a meal shared with friends without fear of deportation.

Those workers that largely go unheard and unseen -- who pick our apples, milk our cows, and clean our hotels -- now have names and faces, not in small part due to the courage and strength of Danilo Lopez, a farmworker who took great risks just to tell his story in hope that it will help future generations of immigrants and farm laborers.

Along with his friend Antonio Meza, he now faces the very real risk of deportation in an incident that clearly would not have had the same outcome if their skin were a different color. We cannot support our farmers without supporting our farmworkers, and we cannot reasonably enforce immigration policies that operate in isolation of the reality of our agricultural needs and practices.

We have seen what the Vermont way looks like in the wake of Irene. Neighbor helping neighbor, communities coming together - the recognition that far more unites us in our common humanity than can ever divide us. Let it be so for our treatment of all who love and live in Vermont, who toil in her farms and produce her agricultural bounty, and who have come out of her shadows to claim their dignity and basic human rights.

It is with this spirit that we, as community leaders and people of color, thank you, Governor Shumlin, for your support of Danilo and Antonio, and for your commitment to the need for responsible, comprehensive federal immigration reform and to the fair and just treatment of all people.

In solidarity with the migrant farmworker leaders you are meeting with on October 14, we respectfully ask that you help clarify the State's Bias Free Policing policies to protect people like Danilo and Antonio, and to help keep all communities safe by directing Vermont police not to act as immigration enforcement agents.

We look forward to working with you on these issues, and to supporting you in your courageous leadership.
